#### **HCNS TUITION POLICIES**

#### Withdrawal Policy

In the event of a withdrawal of a child, the parent must notify the school in writing, by mail or by hand delivery to the Director. We request one month's notice for withdrawal, with exceptions made in cases of immediate re-location out of the area or withdrawal due to medical necessity. The \$100 enrollment deposit is non-refundable in the case of any withdrawal after signing the contract.

#### **Delinquent Accounts**

Tuition payments are due by the first of each month. In the event that payments are more than 90 days late, the school reserves the right to ask your child to leave the school until the account is brought current. If you are having trouble making tuition payments, please get in touch with the director sooner rather than later.

### **Scholarship Funds and Financial Hardship**

HCNS has a limited amount of scholarship funds. If you have requested assistance, please be aware that what we can offer varies from year-to-year with the number of families requesting help, and the amount of money in our scholarship fund.
